waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

10. Estimated time required to construct works 1 1/2 years. The well will be 8-inch diameter, gravel packed, with 50 feet of cemented surface casing, and a submersible pump.

11. Estimated time required to complete the application of water to beneficial use 3 years

12. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.

Up to 12.0 x 10⁶ gal./year will be used for a gold mining and heap leach operation and associated uses, such as dust suppression on haul roads. The principal use of the water will be makeup water for the heap leach facility.
