The applicant WASHOE COUNTY

NEVADA 89520, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is Underground Name of stream, lake, spring, underground or other source

2. The amount of water applied for is 5.0 second-feet One second-foot equals 448.83 gals. per min.

(a) If stored in reservoir give number of acre-feet n/a

3. The water to be used for Quasi-Municipal Irrigation, power, mining, manufacturing, domestic, or other use. Must limit to one use.

4. If use is for:

(a) Irrigation, state number of acres to be irrigated n/a

(b) Stockwater, state number and kinds of animals to be watered n/a

(c) Other use (describe fully under "No. 12. Remarks" see remarks

(d) Power: n/a

(1) Horsepower developed n/a

(2) Point of return of water to stream n/a

5. The water is to be diverted from its source at the following point LONG VALLEY - SW 1/4 SW 1/4 of Section 34, T43N, R19E, M.D.B. & M. at a point from which the SW corner of said survey, and by course and distance to a section corner. If on unsurveyed land, it should be so stated. Section 34, bears S 45° W a distance of 25 feet.

6. Place of use Washoe County as described in NRS 243.340 et seq Describe by legal subdivision. If on unsurveyed land, it should be so stated. Place of use description filed under Application 50191

7. Use will begin about January 1 and end about December 31, of each year. Month and Day Month and Day

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Drilled well, equipped with pump and motor, pipelines, pumping stations, and storage reservoirs. State manner in which water is to be diverted, i.e. diversion structure, ditches and flumes, drilled well with pump and motor, etc.

9. Estimated cost of works \$150,000,000.00

10. Estimated time required to construct works..... 20 years  
If well completed, describe works.

11. Estimated time required to complete the application of water to beneficial use..... 30 years

12. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use. This application and any others filed in this basin by Washoe county are to appropriate all of the unappropriated groundwater. The diversion is anticipated to exceed the perennial yield of the basin for limited periods of time. This limited duration over-pumpage will provide a supplemental supply of water to augment the quasi-municipal use of surface water during droughts or other short-term emergencies and to fill reservoirs. The 20-year average consumptive use will not exceed the perennial yield of the groundwater basin. To allow the basin to replenish its storage by natural means, the normal (non-drought period) consumptive sue will be about 80 to 90 percent of the estimated perennial yield. This water will be commingled with other waters appropriated by Washoe County to serve a county-wide population of 500,000 by the year 2030.
