1. The source of water is Underground

5. The water is to be diverted at the following point SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 35, T 35 N, R 62 E, MDB & M., at a point from which the N $\frac{1}{4}$ corner of said Section 35 bears N 1° 15' 00" W, 1380.30 feet.

6. The existing permitted point of diversion is located within SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 35, T 35 N, R 62 E, MDB & M., at a point from which the E $\frac{1}{4}$ corner of said Section 35 bears S 44° 51' 02" E, 1800.00 feet.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the Point of Diversion of the waters of an underground source as heretofore granted under Permit 33137 is issued subject to the terms and conditions imposed in said Permit 33137 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a measuring device must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 33138 and 50265 shall not exceed 1280 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 4.0 cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before March 7, 1988

Proof of completion of work shall be filed before April 7, 1988

Application of water to beneficial use shall be made on or before March 7, 1988

Proof of the application of water to beneficial use shall be filed on or before April 7, 1988

Map in support of proof of beneficial use shall be filed on or before April 7, 1988


