2. The amount of water to be changed 1.2 cfs

5. The water is to be diverted at the following point SE 1/4 SW 1/4, Sec. 1, T.19 N., R.26 E., M.D.B.& M. or at a point from which the SW 1/4 cor. of said Sec. 1 bears S. 58° 58' 40" W., 1942.5 feet.

6. The existing permitted point of diversion is located within

7. Proposed place of use All of Section 1, T.19 N., R.26 E., M.D.B.& M. 370 acres

8. Existing place of use E 1/2 SW 1/4, NW 1/4 SE 1/4, Sec. 1, T.19 N., R.26 E., M.D.B.& M. 120 acres

9. Use will be from January 1 to December 31 of each year.

10. Use was permitted from January 1 to December 31 of each year.

11. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Drilled well, pump, motor and irrigation system.

12. Estimated cost of works \$15,000.00

13. Estimated time required to construct works 2 years

14. Estimated time required to complete the application of water to beneficial use 5 years

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use of the waters of an underground source as heretofore granted under Permit 43735 is issued subject to the terms and conditions imposed in said Permit 43735 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

No perforations shall be put in the production casing from ground level to 100 feet.

The total combined duty of water under Permits 50442, 50443, 50444 and 50445 shall not exceed 1480 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The place of use of Permits 50442, 50443, 50444 and 50445 is limited to the irrigation of 370 acres within Sec. 1, T.19N., R.26E., M.D.B.&M.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.2 cubic feet per second but not to exceed 240 acre-feet annually

Work must be prosecuted with reasonable diligence and be completed on or before July 21, 1987

Proof of completion of work shall be filed before August 21, 1987

Application of water to beneficial use shall be made on or before July 21, 1988

Proof of the application of water to beneficial use shall be filed on or before August 21, 1988

Map in support of proof of beneficial use shall be filed on or before August 21, 1988
