hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is Underground Sources - Six Mile Well

2. The amount of water applied for is 0.05 c.f.s. second-feet

(a) If stored in reservoir give number of acre-feet

3. The water to be used for Stockwatering

4. If use is for:

(a) Irrigation, state number of acres to be irrigated

(b) Stockwater, state number and kinds of animals to be watered 500 cattle, 2,500 sheep

(1) Horsepower developed

(2) Point of return of water to stream

5. The water is to be diverted from its source at the following point in the NE 1/4 SW 1/4 of Section 24.

T. 17 N., R. 57 E., M.D.B. & M., whence the Southeast Corner of said Section 24 bears S. 69° 47' 34" E., 4,195.38 feet distant.

6. Place of use SW 1/4 of Section 24, T. 17 N., R. 57 E., M.D.B. & M.

7. Use will begin about January 1st and end about December 31st, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Drilling and equipping a well and pumping the water to stockwatering tanks within the proposed place of use.

9. Estimated cost of works \$5,000.00

10. Estimated time required to construct works 3 years
If well completed, describe works.

11. Estimated time required to complete the application of water to beneficial use 5 years

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. It is further understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to any other ground water development in the area. The well shall be equipped with a 2-inch opening for measuring depth to water. If well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

No perforations shall be put in the production casing from ground level to 100 feet.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and

not to exceed 0.0313 cubic feet per second, or sufficient to water

500 head of cattle and 2500 head of sheep.

Work must be prosecuted with reasonable diligence and be completed on or before October 2, 1988

Proof of completion of work shall be filed on or before November 2, 1988

Application of water to beneficial use shall be made on or before October 2, 1990

Proof of the application of water to beneficial use shall be filed on or before November 2, 1990

Map in support of proof of beneficial use shall be filed on or before N/A
