

APPLICATION FOR PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant Kenneth G. Jones of Lamoille, Nevada 89828, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is underground (Sohio well) Name of stream, lake, spring, underground or other source

2. The amount of water applied for is 0.1 second-foot One second-foot equals 448.83 gals. per min.

(a) If stored in reservoir give number of acre-feet

3. The water to be used for stock water and domestic Irrigation, power, mining, manufacturing, domestic, or other use. Must limit to one use.

4. If use is for: (a) Irrigation, state number of acres to be irrigated

(b) Stockwater, state number and kinds of animals to be watered 900 cattle

(c) Other use (describe fully under "No. 12. Remarks")

(d) Power: (1) Horsepower developed (2) Point of return of water to stream

5. The water is to be diverted from its source at the following point within the SW 1/4 SE 1/4 Section 11, T.30N., R.60E., M.D.M., from which the SE corner of said section bears S.84°26'10"E., 2176.25 ft. dist.

6. Place of use SW 1/4 SE 1/4 Sec. 11, T.30N., R.60E., M.D.M. Describe by legal subdivision. If on unsurveyed land, it should be so stated.

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) drilled well, casing, submersible pump small storage tank and stock troughs

9. Estimated cost of works \$10,000.00

10. Estimated time required to construct works..... two years

APPROVAL.....OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. It is further understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to any other ground water development in the area. The well shall be equipped with a 2-inch opening for measuring depth to water. If well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed..... 0.03cubic feet per second, or sufficient to water 900 head of cattle.

Work must be prosecuted with reasonable diligence and be completed on or before..... June 3, 1989

Proof of completion of work shall be filed on or before..... July 3, 1989

Application of water to beneficial use shall be made on or before..... June 3, 1990

Proof of the application of water to beneficial use shall be filed on or before..... July 3, 1990
