This permit to change the place of use of a portion of the waters of Carson River as heretofore granted under Permit 46521 is issued subject to the terms and conditions imposed in said Permit 46521

and with the understanding that no other rights on the source will be affected by the change proposed herein. A substantial headgate and measuring device must be installed and maintained to facilitate the measurement and control of water. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies,

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed..... 0.729..... cubic feet per second., but not to exceed 108.43 acre-feet as decreed.
