6. Place of use Lot 759 of Green Saddle Ranch, situated in the Southeast Quarter of the Northwest Quarter of Section 19, Township 21 South, Range 54 East, Mount Diablo Meridian, Pahrump Town, Nye County, Nevada.

7. Use will begin about January 1 and end about December 31, of each year.
