hereby makes application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

January, 1961, in the State of Nevada

1. The source of the proposed appropriation is Seeding Spring No. 1

2. The amount of water applied for is 0.01 c.f.s. second-feet

(a) If stored in reservoir give number of acre-feet

3. The water to be used for Stockwatering

4. If use is for:

(a) Irrigation, state number of acres to be irrigated

(b) Stockwater, state number and kinds of animals to be watered 300 head of cattle

(c) Other use (describe fully under "No. 12. Remarks")

(d) Power:

(1) Horsepower developed

(2) Point of return of water to stream

5. The water is to be diverted from its source at the following point in the NW 1/4 NW 1/4 of Section 17,

T.19 N., R.63 E., M.D.B. & M., whence the Southwest Corner of Section 8, T.19 N., survey, and by course and distance to a section corner. If on unsurveyed land, it should be so stated.

R.63 E., M.D.B. & M. bears N.37°03'W., 1,205.00 feet distant.

6. Place of use NW 1/4 NW 1/4 of Section 17, T.19 N., R.63 E., M.D.B. & M.

7. Use will begin about January 1st and end about December 31st, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Develop spring area and divert the water to a stockwatering trough

9. Estimated cost of works \$3,000.00

10. Estimated time required to construct works 3 years.  
If well completed, describe works.

11. Estimated time required to complete the application of water to beneficial use 5 years.

12. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

This permit is subject to the condition that the permittee must ensure that wildlife which have customarily used such water will have access thereto, NRS 533.367.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.009 cubic feet per second or sufficient to water 300 head of cattle.

Work must be prosecuted with reasonable diligence and be completed on or before March 30, 1990

Proof of completion of work shall be filed on or before April 30, 1990

Application of water to beneficial use shall be made on or before March 30, 1992

Proof of the application of water to beneficial use shall be filed on or before April 30, 1992

Map in support of proof of beneficial use shall be filed on or before N/A
