hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

- 1. The source of the proposed appropriation is underground
2. The amount of water applied for is 1.0 c.f.s.
3. The water to be used for mining, milling and domestic purposes
4. If use is for: (a) Irrigation, state number of acres to be irrigated...

5. The water is to be diverted from its source at the following point SE 1/4 SE 1/4 Section 34, T.29N., R.34E., M.D.B.&M., or at a point from where the Southeast corner of said Section 34 bears survey, and by course and distance to a section corner.

6. Place of use SW 1/4 Section 35 and the S 1/2 SE 1/4 Section 36 all in T.29N., R.34E., M.D.B.&M.

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) pump and motor, through pipeline to storage ponds

9. Estimated cost of works \$5,000.00

10. Estimated time required to construct works 2 years
If well completed, describe works.

11. Estimated time required to complete the application of water to beneficial use 5 years

12. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.
