hereby make application for permission to change the point of diversion and place of use of a portion of water heretofore appropriated under permit 49064  
(Identify existing right by Permit, Certificate, Proof or Claim Nos. If Decreed, give title of Decree and identify right in Decree.)

1. The source of water is underground

2. The amount of water to be changed 2.02 AF .004 CFS

4. The water heretofore permitted for Quasi-municipal and domestic

5. The water is to be diverted at the following point NE 1/4 SE 1/4, Section 7, T.19N, R.18E, M.D.B.M.  
Describe as being within a 40-acre subdivision of public survey and by course and distance to a section corner. If on unsurveyed land, it should be stated.  
AND FROM WHICH POINT the east quarter section corner of said Section 7 bears N. 77° 15' E a distance of 1110 feet.

6. The existing permitted point of diversion is located within the NW 1/4 SW 1/4 Section 8, T. 19N., R.18 E, M.D.B.M.,  
If point of diversion is not changed, do not answer.  
or at a point from which the SW corner of said section 8 bears south 19° 19' 55" west 2701.09 feet.

7. Proposed place of use NE 1/4 SE 1/4, Section 7, T.19N, R 18E, M.D.B.M., well no. 57

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 49064 is issued subject to the terms and conditions imposed in said Permit 49064 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The issuance of Permits 51649 through 51707, inclusive, reduces the total combined duty of water under Permits 34591, 46998, 47000, 47171, 47351, 47611, 47683, 47787, 49064, 49065, 49066, 49067, 49068, 49069, 49586, 49587, 49588 and 49589 to 306.98 acre-feet annually.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.004 cubic feet per second, but not to exceed 2.02 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before April 22, 1990

Proof of completion of work shall be filed before May 22, 1990

Application of water to beneficial use shall be made on or before April 22, 1992

Proof of the application of water to beneficial use shall be filed on or before May 22, 1992

Map in support of proof of beneficial use shall be filed on or before N/A
