APPLICATION FOR PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant Frank Vuckovic, Sr.
3178 Chapala Dr., of Las Vegas, Nevada 89120, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

- 1. The source of the proposed appropriation is underground - Las Vegas Artesian Basin
2. The amount of water applied for is 0.015 second-feet
3. The water to be used for Quasi - Municipal, Domestic
4. If use is for: (a) Irrigation, state number of acres to be irrigated. (b) Stockwater, state number and kinds of animals to be watered. (c) Other use (describe fully under "No. 12. Remarks"). Domestic (d) Power: (1) Horsepower developed. (2) Point of return of water to stream.
5. The water is to be diverted from its source at the following point within the NE 1/4 SE 1/4, Section 16, T.22S., R.61E., M.D.M. from which the E 1/4 corner bears N43°01'17"E a distance of 1668.9'.
6. Place of use SW 1/4 SW 1/4 NE 1/4 SE 1/4, Section 16, T.22S., R.61E., M.D.M.
7. Use will begin about January 1st and end about December 31st, of each year.
8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Water will be piped from well to homes.
9. Estimated cost of works \$20,000.00

10. Estimated time required to construct works..... Well is existing. 12 1/2" well cased with 8" to 305'.
If well completed, describe works.

11. Estimated time required to complete the application of water to beneficial use..... 24 months

12. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.

Water will be used for three (3) homes each on its own lot.

APPROVAL.....OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights and is further subject to revocation if and when water can be furnished by an entity such as a water district or a municipality engaged in furnishing water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. It is understood that this right must allow for a reasonable lowering of the static water level. The well shall be equipped with a 2-inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed..... 0.015.....cubic feet per second, but not to exceed 1.095 million gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before..... December 21, 1991

Proof of completion of work shall be filed on or before..... January 21, 1992

Application of water to beneficial use shall be made on or before..... December 21, 1994

Proof of the application of water to beneficial use shall be filed on or before..... January 21, 1995

Map in support of proof of beneficial use shall be filed on or before..... N/A
