This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.093 cubic feet per second, or sufficient to water 2,000 head of cattle and 5,000 head of sheep.

Work must be prosecuted with reasonable diligence and be completed on or before September 4, 2000

Proof of completion of work shall be filed on or before October 4, 2000

Application of water to beneficial use shall be made on or before September 4 2003

(PERMIT TERMS CONTINUED)

This permit is subject to the condition that the permittee must ensure that wildlife which have customarily used such water will have access thereto, NRS 533.367.

The total combined duty of water under Permits 52477, 52478, 52479, 52480, 52481, 52482, 52483, and 52484 shall not exceed the sufficient amount to water 2,000 head of cattle and 5,000 head of sheep.
