This is to certify I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place and manner of use of the waters of West Queen Spring #1, 2, and 3 as heretofore granted under Permit 21451, Certificate 7818 is issued subject to the terms and conditions imposed in said Permit 21451, Certificate 7818 and with the understanding that no other rights on the source will be affected by the change proposed herein. A measuring device must be installed and measurements of water use kept.

The total combined duty of water under Permits 52674 through 52681 shall not exceed 12.839 million gallons annually.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0217 cubic feet per second, but not to exceed 1.43 million gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before March 27, 1991

Proof of completion of work shall be filed before April 27, 1991

Application of water to beneficial use shall be made on or before March 27, 1993

Proof of the application of water to beneficial use shall be filed on or before April 27, 1993
