The intent of this application is to allow the applicant the ability to pump the total duty resulting from the expansion of their previously permitted diversion rate and to increase the total combined duty of the applicant's five existing supplemental wells, together with one new well, to 331.205 mga. (See 9/8/88 letter to the Division of Water Resources). This application is the same point of diversion as Permit 51265. It is the intent of the applicant to withdraw Permit 51265 upon approval of the new appropriations.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level. This well shall be equipped with a two (2) inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins or before the Proof of Completion of Work is filed.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

No perforations shall be put in the production casing from ground level to 100 feet.

The total combined duty of water under Permits 51265, 51933, 51935, 51936, 52339, 52750, 52751, 52752, 52753, 52754 and 52755 shall not exceed 331.2 million gallons annually.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.4 cubic feet per second but not to exceed 94.4

million gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before April 7, 1990

Proof of completion of work shall be filed on or before May 7, 1990

Application of water to beneficial use shall be made on or before April 7, 1991

Proof of the application of water to beneficial use shall be filed on or before May 7, 1991
