hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is Upper Cottonwood Spring Name of stream, lake, spring, underground or other source

2. The amount of water applied for is 0.032 second-feet One second-foot equals 448.83 gals. per min.

(a) If stored in reservoir give number of acre-feet.

3. The water to be used for Stockwater Irrigation, power, mining, manufacturing, domestic, or other use. Must limit to one use.

4. If use is for:

(a) Irrigation, state number of acres to be irrigated.

(b) Stockwater, state number and kinds of animals to be watered. 1000 cattle, 25 horses

(c) Other use (describe fully under "No. 12. Remarks").

(d) Power:

(1) Horsepower developed.

(2) Point of return of water to stream.

5. The water is to be diverted from its source at the following point SE 1/4 SE 1/4, Sec. 26, T.2N., R.49E., M.D.B. & M., or at a point from which the NE Cor. Sec. 4, T.1N., R.50E., M.D.B. & M. bears S 73°53' E a distance of 21,300 feet.

6. Place of use SE 1/4 SE 1/4, Sec. 26, T.2N., R.49E., M.D.B. & M. Describe by legal subdivision. If on unsurveyed land, it should be so stated.

7. Use will begin about January 1 and end about December 31 of each year. Month and Day

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

This permit is subject to the condition that the permittee must ensure that wildlife which have customarily used such water will have access thereto, NRS 533.367.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.032 cubic feet per second, or sufficient to water

1,000 head of cattle and 25 head of horses.

Work must be prosecuted with reasonable diligence and be completed on or before June 28, 1990

Proof of completion of work shall be filed on or before July 28, 1990

Application of water to beneficial use shall be made on or before June 28, 1991

Proof of the application of water to beneficial use shall be filed on or before July 28, 1991

Map in support of proof of beneficial use shall be filed on or before N/A
