Nevada 89101, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is Underground, Las Vegas Artesian Basin

2. The amount of water applied for is 0.0039 second-foot

(a) If stored in reservoir give number of acre-feet

5. The water is to be diverted from its source at the following point NE 1/4 of the NE 1/4, Section 35, T21S., R60E., M.D.M., from which point the Northeast corner of said Section 35 bears

North 29° 30' 01" East a distance of 1126.43 feet.

6. Place of use The NE 1/4 of the NE 1/4, Section 35, T21S., R60E., M.D.M.

7. Use will begin about January 1st and end about December 31st, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Eight (8") inch well cased to 435 ft. Five (5)

H.P. Grunfose pump. Two 75 gallon well mate tanks.

9. Estimated cost of works Ten thousand dollars (\$10,000.00)

10. Estimated time required to construct works..... One (1) year.

11. Estimated time required to complete the application of water to beneficial use. One (1) year.

APPROVAL .....OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights and is further subject to revocation if and when water can be furnished by an entity such as a water district or a municipality engaged in furnishing water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. It is understood that this right must allow for a reasonable lowering of the static water level. The well shall be equipped with a 2-inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0039 cubic feet per second, but not to exceed 0.92 million gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before August 6, 1992

Proof of completion of work shall be filed on or before September 6, 1992

Application of water to beneficial use shall be made on or before August 6, 1995

Proof of the application of water to beneficial use shall be filed on or before September 6, 1995

Map in support of proof of beneficial use shall be filed on or before N/A
