

APPLICATION FOR PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant Charlotte Kim 5901 So. Jones Nevada 89118 of Las Vegas hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

(If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is Underground - Las Vegas Artesian Basin

2. The amount of water applied for is 0.03 second-feet

(a) If stored in reservoir give number of acre-feet

3. The water to be used for Quasi-Municipal, Domestic

4. If use is for:

(a) Irrigation, state number of acres to be irrigated

(b) Stockwater, state number and kinds of animals to be watered

(c) Other use (describe fully under "No. 12. Remarks") Domestic

(d) Power:

(1) Horsepower developed

(2) Point of return of water to stream

5. The water is to be diverted from its source at the following point within the SE 1/4 NE 1/4, Section 35, T 21-S, R 60E, M.D.M. from which the E 1/4 Corner bears S 27°-56'-35" E 1194.58'.

6. Place of use NW 1/4 NE 1/4 SE 1/4 NE 1/4, Section 35, T21 S, R 60E, M.D.M.

7. Use will begin about January 1st and end about December 31st of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Water will be diverted through pipes from well to place of use.

9. Estimated cost of works \$20,000.00

10. Estimated time required to construct works..... 24 Months. Well is existing, 12" in diameter cased
8" to 300'. If well completed, describe works.

11. Estimated time required to complete the application of water to beneficial use..... 36 Months

12. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.

Water will be used by two families each on their own lot.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights and is further subject to revocation if and when water can be furnished by an entity such as a water district or a municipality engaged in furnishing water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. It is understood that this right must allow for a reasonable lowering of the static water level. The well shall be equipped with a 2-inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.03 cubic feet per second, but not to exceed 0.73 million gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before December 21, 1991

Proof of completion of work shall be filed on or before January 21, 1992

Application of water to beneficial use shall be made on or before December 21, 1994

Proof of the application of water to beneficial use shall be filed on or before January 21, 1995

Map in support of proof of beneficial use shall be filed on or before N/A

Completion of work filed MAY - 5 1992
