APPLICATION FOR PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant Halstead-Forsgren Ranches, Inc.

Nevada 89301, hereby make application for permission to appropriate the public

waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is Bog Spring Name of stream, lake, spring, underground or other source

2. The amount of water applied for is 0.5 cfs second-foot One second-foot equals 448.83 gals. per min.

(a) If stored in reservoir give number of acre-feet

3. The water to be used for Irrigation and Domestic Irrigation, power, mining, manufacturing, domestic, or other use. Must limit to one use.

4. If use is for:

(a) Irrigation, state number of acres to be irrigated 320 acres

(b) Stockwater, state number and kinds of animals to be watered

(c) Other use (describe fully under "No. 12. Remarks")

(d) Power:

(1) Horsepower developed

(2) Point of return of water to stream

5. The water is to be diverted from its source at the following point in the SE 1/4 NW 1/4 of Section 36, T.14 N., R. 56 E., M.D.M. & M., whence the East 1/4 Corner of Section 25, T.14 N., R.56 E., M.D.B. & M. bears N. 38° 38' 15" E., 6,245.52 feet distant.

6. Place of use SE 1/4 NW 1/4, E 1/2 SW 1/4 of Section 36, T.14 N., R.56 E., M.D.B. & M., NE 1/4 NW 1/4, SW 1/4 NE 1/4, W 1/2 SE 1/4 of Section 1, NW 1/4 NE 1/4 of Section 12, T13 N., R.56 E., M.D.B. & M.

7. Use will begin about January 1st and end about December 31st of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) The water will be diverted through "v" ditches and pipelines to the proposed place of use and irrigated with a sprinkler system.

9. Estimated cost of works \$10,000.00

10. Estimated time required to construct works..... 3 years
If well completed, describe works.

11. Estimated time required to complete the application of water to beneficial use..... 5 years

12. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use.

This application will be used in conjunction with Nos. 16800, 16801, 53160, 53161 and 53162 to irrigate the place of use for a total seasonal duty of 4.0 acre feet per acre.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the 0.5 c.f.s., herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to a beneficial use. A suitable measuring device must be installed and accurate measurements of the water placed to a beneficial use must be included in the proof of such use when filed. The State retains the right to regulate the use of the water herein granted at any and all times.

The total combined duty of water under Permits 16800, 16801, 53160, 53161, 53162, and 53163 shall not exceed 3,520 acre-feet annually.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

This permit is subject to the condition that the permittee must ensure that wildlife which have customarily used such water will have access thereto, NRS 533.367.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.5 cubic feet per second, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources, but not to exceed 362 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before November 20, 1991

Proof of completion of work shall be filed on or before December 20, 1991

Application of water to beneficial use shall be made on or before November 20, 1993

Proof of the application of water to beneficial use shall be filed on or before December 20, 1993

Map in support of proof of beneficial use shall be filed on or before December 20, 1993

Completion of work filed JAN 21 1993

Proof of beneficial use filed
