This is to certify I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use of a portion of the waters of the Truckee River as heretofore granted under Claim 86, Truckee River Final Decree is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.014 cubic feet per second, but not to exceed 2.8 acre-feet as decreed.

Work must be prosecuted with reasonable diligence and be completed on or before July 9, 1993

Proof of completion of work shall be filed before August 9, 1993

Application of water to beneficial use shall be made on or before July 9, 1995

Proof of the application of water to beneficial use shall be filed on or before August 9, 1995

Map in support of proof of beneficial use shall be filed on or before N/A
