Applications 53473 through 53554, inclusive, 53556, 53557, 53559 through 53565, inclusive, 53567 through 53576, inclusive, 53578 through 53582, inclusive, 53585 through 53588, inclusive, are hereby denied on the grounds that the applicants have not submitted the information requested by the State Engineer's office, that without this information the granting of the applications would be detrimental to the public interest, and that the applicants have not sufficiently demonstrated a reasonable expectation to apply the water from 110 different sources to the intended beneficial use.
