hereby make... application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is an underground source

2. The amount of water applied for is 0.006 c.f.s. second-feet
One second-foot equals 448.83 gals. per min.

The water is to be diverted from its source at the following point within the NE 1/4 of the SE 1/4 of Section 25, Township 19 South, Range 59 East, M.D.B. & M., or at a point from which the East survey, and by course and distance to a section corner. If on unsurveyed land, it should be so stated.

Quarter (E 1/4) corner of said Section 25 bears North 74°20'54" East a distance of 1344.09 feet.

6. Place of use within the NE 1/4 of the SE 1/4 of Section 25, Township 19 South, Range 59 East, Describe by legal subdivision. If on unsurveyed land, it should be so stated.

M.D.B. & M., approximately five (5.0) acres.

7. Use will begin about January 1st and end about December 31st, of each year.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights and is further subject to revocation if and when water can be furnished by an entity such as a water district or a municipality engaged in furnishing water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. It is understood that this right must allow for a reasonable lowering of the static water level. The well shall be equipped with a 2-inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed..... 0.006 cubic feet per second... but not to exceed 1.42 million gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before..... December 13, 1992

Proof of completion of work shall be filed on or before..... January 13, 1993

Application of water to beneficial use shall be made on or before..... December 13, 1995

Proof of the application of water to beneficial use shall be filed on or before..... January 13, 1996

Map in support of proof of beneficial use shall be filed on or before..... N/A
