4. The water heretofore permitted for Quasi-Irrigation and Domestic

5. The water is to be diverted at the following point "Well 13" located in Lot 4, Section 6, T.20N., R.21E., M.D.M., from which the NW corner of said Section 6 bears North 01°08'00" West, 985.00 feet.

6. The existing permitted point of diversion is located within SE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 23, T.21N., R.20 E., M.D.M. from which the N $\frac{1}{4}$ corner of Section 24, T.21N., R.20E., M.D.M. bears North 60°21'23" East, 3318.28 feet (Permit No. 30153).
