APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 36023 is issued subject to the terms and conditions imposed in said Permit 36023 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a measuring device must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 54827, 54828, 54829, 54830, 54831, 54832, 54833, 54834, 54835, 54836, 54837, 54838 and 54839, shall not exceed 14,600.28 acre-feet annually.

This permit is issued subject to the Water Management Plan and Addendum among Barrick Goldstrike Mines, Inc.; Newmont Gold Company; and the TS Ranch Joint Venture dated May 1, 1989.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 5.4 cubic feet per second, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before March 4, 1992

Proof of completion of work shall be filed before April 4, 1992

Application of water to beneficial use shall be made on or before March 4, 1993

Proof of the application of water to beneficial use shall be filed on or before April 4, 1993

Map in support of proof of beneficial use shall be filed on or before April 4, 1993
