hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is Las Vegas Artesian Basin (underground)

2. The amount of water applied for is .0092 second-feet

MDB&M or at a point from which the E1/16 corner of said Section 31 bears South

26° 26' 03" West a distance of 393.61 feet.

6. Place of use a portion of the SE 1/4 SE 1/4 Section 31 T19S, R60E MDB&M

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works: (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) 545 feet of well casing 8 inches in diameter equipped with a 3hp submersible pump and a 2hp booster pump and 5000 gal storage.

9. Estimated cost of works \$15,000.00

10. Estimated time required to construct works 1 year casing exists at this time

11. Estimated time required to complete the application of water to beneficial use 3 years

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights and is further subject to revocation if and when water can be furnished by an entity such as a water district or a municipality engaged in furnishing water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. It is understood that this right must allow for a reasonable lowering of the static water level. The well shall be equipped with a 2-inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This Permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0092 cubic feet per second, ~~but not to exceed 1.46~~ million gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before November 19, 1993

Proof of completion of work shall be filed on or before December 19, 1993

Application of water to beneficial use shall be made on or before November 19, 1996

Proof of the application of water to beneficial use shall be filed on or before December 19, 1996

Map in support of proof of beneficial use shall be filed on or before N/A
