The applicant City of Mesquite

hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) March 9, 1984 in the Eighth Judicial District Court of the State of Nevada, County of Clark.

1. The source of the proposed appropriation is Underground

2. The amount of water applied for is 10 cfs second-feet

3. The water to be used for Municipal and Domestic

4. If use is for:

(2) Point of return of water to stream

5. The water is to be diverted from its source at the following point located in unsurveyed land within the

SE 1/4 of the SW 1/4 of Sec. 32, T8S, R71E from which the N 1/4 corner of Sec. 32, T8 1/2 S,

R71E, M.D.M. bears S 74 0 01' 21" W, 808.96 ft. distant.

6. Place of use T13S, R71E, M.D.M., Sections 3,4,5,7,8,9,10,15,16,17,18,19,20,21,30

T13S, R70E, M.D.M., Sections 12,13 S 1/2 of Sec. 14, Sec. 23,24,25,26,27,34,35

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Drilled wells with pumps & motors, transmission line to City of Mesquite storage facilities.

9. Estimated cost of works \$5-15 million

10. Estimated time required to construct works..... 5 years

11. Estimated time required to complete the application of water to beneficial use..... 7 years

The intended use for the water is to serve as primary municipal and domestic water source for the City of Mesquite. The City currently has a population of 1600 and is experiencing a growth rate of approximately 18% per annum.
