hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

Incorporated on March 12, 1980 in Colorado.

The water is to be diverted from its source at the following point within an unsurveyed 40-acre subdivision estimated to be at SE 1/4 NW 1/4, Section 14 based upon the official protraction diagram of Township 23 North, Range 35 East M.D.B.&M. from which the well location survey, and by course and distance to a section corner. If on unsurveyed land, it should be so stated. bears N. 00° 29' W. a distance of 2900.0 feet; bears from a U.S.C.&G.D. benchmark 3411 (C104)

6. Place of use Within Sections 11, 12, 13, 14 Township 23 North, Range 35 East, MDB&M Churchill County, Nevada. All of the said lands are located within unsurveyed sections.

7. Use will begin about January 1 and end about December 31, of each year.

Annual use from all sources will not exceed 724 acre-feet per year. NOTE**Bearings are based on Santa Fe Gold local coordinate grid between two existing USC & GS bench mark monuments. Bearing and distance being N. 33° 11' 11" E. 555.25'.
