hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is underground Name of stream, lake, spring, underground or other source

5. The water is to be diverted from its source at the following point THE NE 1/4 OF THE SW 1/4 OF SECTION 32, T.19S., R.60E., M.D.B.&M., CLARK COUNTY, NEVADA: THE WELL BEING N. 52°19'12" E., 2301.08 FEET FROM THE SW CORNER OF SECTION 32, T.19S., R.60E., M.D.B.&M.

6. Place of use THE SE 1/4 OF THE SW 1/4 OF THE NE 1/4 OF THE SW 1/4 OF SECTION 32, T.19S., R.60E., M.D.B.&M.

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Drilled with well pump, motor and storage tank

9. Estimated cost of works \$20,000.00

10. Estimated time required to construct works 12 months

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights and is further subject to revocation if and when water can be furnished by an entity such as a water district or a municipality engaged in furnishing water. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. It is understood that this right must allow for a reasonable lowering of the static water level. The well shall be equipped with a 2-inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.01 cubic feet per second, but not to exceed 1.095 million gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before January 24, 1993

Proof of completion of work shall be filed on or before February 24, 1993

Application of water to beneficial use shall be made on or before January 24, 1996

Proof of the application of water to beneficial use shall be filed on or before February 24, 1996

Map in support of proof of beneficial use shall be filed on or before N/A
