Point of Diversion and Place of Use of water heretofore appropriated under Permit No. 52456

1. The source of water is underground

2. The amount of water to be changed 0.249 CFS 180.0 AFA

3. The water to be used for irrigation

4. The water heretofore permitted for irrigation

5. The water is to be diverted at the following point NW 1/4 NW 1/4 Section 16, T. 22 N., R. 21 E., M.D.M., at a point from which the southwest corner of said Section 16 bears South 10°56'12" West, 4079.29 feet (Well-5)

6. The existing permitted point of diversion is located within NW 1/4 NE 1/4 Section 8, T. 22 N., R. 21 E., M.D.M., at a point from which the northwest corner of said Section 8 bears North 65°25'00" West, 3191.59 feet (Well-6)

7. Proposed place of use See attached Item 7.

8. Existing place of use Section 8, T. 22 N., R. 21 E., M.D.M., SE 1/4 NE 1/4; NE 1/4 SE 1/4; SE 1/4 SE 1/4; Section 9, T. 22 N., R. 21 E., M.D.M., SW 1/4 NW 1/4; NW 1/4 SW 1/4 - Total 45.0 acres.

9. Use will be from January 1 to December 31 of each year.

10. Use was permitted from January 1 to December 31 of each year.

11. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Existing well, pump, pipeline and sprinklers.

12. Estimated cost of works \$10,000

13. Estimated time required to construct works 3 years (Well-5)

14. Estimated time required to complete the application of water to beneficial use... 5 years

15. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use:

This application together with applications to change Permit No.'s 28445, 50867, 50873 and 50874 would allow use of water on any portion of land owned by Nevada Potato, with a combined duty of 544 AFA. This application is not supplemental to water rights appurtenant to this property, but owned by others with no fee interest in the land.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 52456 is issued subject to the terms and conditions imposed in said Permit 52456 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water and place of use under Permits 55603, 55604, 55605, 55606 and 55607 shall be limited to 544 acre-feet annually and 136 acres within the area described under the place of use.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.249 cubic feet per second, but not to exceed 180 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before April 17, 1993

Proof of completion of work shall be filed before May 17, 1993

Application of water to beneficial use shall be made on or before April 17, 1995

Proof of the application of water to beneficial use shall be filed on or before May 17, 1995

Map in support of proof of beneficial use shall be filed on or before May 17, 1995

Completion of work filed JUN 10 1993

Proof of beneficial use filed SEP 02 1993
