Evans**, hereby make application for permission to change the **Place of Use of 8.0 Acres.** of water heretofore appropriated under **Permit #2573 (Certificate 710)** as shown on the attached map (said change being only a portion of **Permit #2573**)

7. Proposed place of use **A portion of NE<sup>1</sup>/<sub>4</sub> NW<sup>1</sup>/<sub>4</sub> of Section 28, T.33 N., R.58 E., M.D.B.&M., Elko County, Nevada, see attached map. See Item #5 as shown on the attached map, parcel #5 of the Division of Large Parcels, Dysart Ranch.**
8. Existing place of use **A portion of NW<sup>1</sup>/<sub>4</sub> of Section 28, T.33N., R.58E., M.D.B.&M., see attached map, Lot 3, Dysart Ranch #2 and roads bordering Dysart #1.**
9. Use will be from **April 15 to October 1** of each year.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use of a portion of the waters of Talbot Creek as heretofore granted under Permit 2573, Certificate 710 is issued subject to the terms and conditions imposed in said Permit 2573, Certificate 710 and with the understanding that no other rights on the source will be affected by the change proposed herein. A substantial headgate and measuring device must be installed and maintained to facilitate the measurement and control of water. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.08 cubic feet per second, but not to exceed 24.0 acre-feet seasonally, and not to exceed a seasonal duty of 3.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:

June 8, 2001

Proof of completion of work shall be filed before:

July 8, 2001

Water must be placed to beneficial use on or before:

June 8, 2002

Proof of the application of water to beneficial use shall be filed on or before:

July 8, 2002

Map in support of proof of beneficial use shall be filed on or before:

July 8, 2002
