APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit to change the place of use of a portion of the waters of an underground source as heretofore granted under Permit 31710 is issued subject to the terms and conditions imposed in said Permit 31710 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 56450, 56451, 56452, 56453 and 56454 shall not exceed 152.94 million gallons annually.

The issuance of this permit totally abrogates Permit 31710.

This permit will allow for an additional 279 existing parcels as described in the place of use to be served at a rate of 600 gallons per day per parcel which is the same duty for the existing 419 lots within Stagecoach Units 1, 2 and 3 and Desert Meadows Subdivisions.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed..... 3.0 cubic feet per second, but not to exceed 122.35 million gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before..... November 21, 1992

Proof of completion of work shall be filed before..... December 21, 1992

Application of water to beneficial use shall be made on or before..... November 21, 1994

Proof of the application of water to beneficial use shall be filed on or before..... December 21, 1994
