ITEM 7 - PROPOSED PLACE OF USE

All of T.15 N., R.20 E., MDB&M; E $\frac{1}{2}$ of T.15 N., R.19 E., MDB&M; Sections 2, 3, and 4, E $\frac{1}{2}$ Section 5, and that portion of the N $\frac{1}{2}$ NE $\frac{1}{2}$ Section 6 which lies within Carson City limits, T.14 N., R.20 E., MDB&M; Sections 31, 32, 33, 34, and 35, W $\frac{1}{2}$ Section 36, and those portions of the E $\frac{1}{2}$ Section 36 which lie within Carson City limits T.16 N., R.20 E., MDB&M; the S $\frac{1}{2}$ of Sections 34, 35, and 36, NE $\frac{1}{2}$ Section 36, and those portions of the SW $\frac{1}{2}$ NW $\frac{1}{2}$ Section 36 and the S $\frac{1}{2}$ NE $\frac{1}{2}$ Section 35 which lie within the Carson City limits T.16 N., R.19 E., MDB&M.

ITEM 15 - REMARKS

Please use maps on file at the Division of Water Resources under Application 35277 to support the proposed point of diversion, under Application 48884 to support the proposed place of use, under Application 50632 to support the existing point of diversion, and under Application 51898 to support the existing place of use. This application is one of two applications being filed concurrently to change the portion of Claim 706 owned by Michael Darling. It is the intent of these applications to change the total acreage owned by Michael Darling under Claim 706 (see attached letter). These applications will become part of the Carson City water system as have previously approved Applications to Change Claims 704 and 705. Appropriation under these applications would be under the express supervision of the Federal Water Master and the Division of Water Resources. Complete records of all diversions will continue to be provided by Carson City to the Division of Water Resources on a monthly basis.
