APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 47546, Certificate 12106 is issued subject to the terms and conditions imposed in said Permit 47546, Certificate 12106 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 56906, 56907, 58436 and 58437 shall not exceed 350.8 acre-feet annually.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.24 cubic feet per second, but not to exceed 63.14 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before December 6, 1994

Proof of completion of work shall be filed before January 6, 1995

Application of water to beneficial use shall be made on or before December 6, 1998

Proof of the application of water to beneficial use shall be filed on or before January 6, 1999

Map in support of proof of beneficial use shall be filed on or before N/A
