The applicant **Joe B. Fallini, Jr. & Susan L. Fallini**, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

This permit is subject to the condition that the permittee must ensure that wildlife which have customarily used such water will have access thereto, NRS 533.367.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permit 56994 and Proof 05639 shall not exceed 0.032 cubic feet per second, or sufficient to water 1000 head of cattle and 25 head of horses.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.032 cubic feet per second, or sufficient to water 1000 head of cattle and 25 horses.

Work must be prosecuted with reasonable diligence and be completed on or before:

September 17, 2002

Proof of completion of work shall be filed before:

October 17, 2002

Water must be placed to beneficial use on or before:

September 17, 2003

Proof of the application of water to beneficial use shall be filed on or before:

October 17, 2003




