APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This temporary permit to change the point of diversion, place of use and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 45477 is issued subject to the terms and conditions imposed in said Permit 45477 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 57131-T and 57132-T shall not exceed 4.0 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on February 1, 1993 at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed..... 0.1 ..... cubic feet per second, but not to exceed 2.0 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before.....

## 15. Remarks

The applicant has entered into a Water Rights Lease Agreement with The Lepire Trust of 1977 (original lease being filed concurrently). This application is for a temporary permit to allow use of the leased water at the Silver Springs airport while pending Application 57077 is being processed. As indicated in Application 57077, the Applicant is a non profit corporation which leases the airport property from the Bureau of Land Management and the Nevada Department of Transportation. Copies of these leases were filed with Applications 57077 and 57078. Water will be used for construction as well as for aviation related activities such as a flight school, shop, hangers, offices, watchman quarters, fire protection, landscaping and related commercial activities. It is intended that this application, together with a second application in the name of Lahontan Airport Development Association being filed concurrently, be supplemental for a total combined duty not to exceed 4 acre-feet annually. Please use maps on file at the Division of Water Resources under Application 57077 to support the proposed point of diversion and place of use, and under Application 45477 to support the existing point of diversion and place of use.
