6. The existing permitted point of diversion is located within SW 1/4 SE 1/4 Sec 2, T11N, R25E, MDB & M or at a point from which the SE corner of said Sec 2 bears S 88° 27' 00" E a distance of 2629.00'

8. Existing place of use Portions of : N 1/2 NE 1/4, NE 1/4 NW 1/4 Sec 12, S 1/2 SE 1/4, NE 1/4 SE 1/4 Sec 1, T11N, R25E, MDB & M, 215.16 acres

9. Use will be from January 1 to December 31 of each year.

10. Use was permitted from January 1 to December 31 of each year.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of the waters of an underground source as heretofore granted under Permit 49251 is issued subject to the terms and conditions imposed in said Permit 49251 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 49250, 49323, 54419, 54645, 57261 and 57262 shall not exceed 954.36 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.107 cubic feet per second, but not to exceed 801.57 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before September 14, 1993.

Proof of completion of work shall be filed before October 14, 1993.

Application of water to beneficial use shall be made on or before September 1, 1994.

Proof of the application of water to beneficial use shall be filed on or before October 1, 1994.

Map in support of proof of beneficial use shall be filed on or before October 14, 1994.
