1. The source of water is underground Name of stream, lake, underground spring or other source.

2. The amount of water to be changed (112.5 acre-feet) 0.16 c.f.s. Second feet, acre feet. One second foot equals 448.83 gallons per minute.

3. The water to be used for irrigation Irrigation, power, mining, industrial, etc. If for stock state number and kind of animals.

4. The water heretofore permitted for irrigation Irrigation, power, mining, industrial, etc. If for stock state number and kind of animals.

5. The water is to be diverted at the following point within the SW 1/4 SE 1/4 Section 33, T.3S.,

R.55E., M.D.M., from which the SE corner of said section bears distance to a section corner. If on unsurveyed land, it should be stated.

6. The existing permitted point of diversion is located within the SW 1/4 NE 1/4 Section 2, T.4S.,

R.55E., M.D.M., from which the NE corner of Sec.35, T.3S., R.55E.,

bears N.11°55'26"E., 6,890.26 ft. dist.

7. Proposed place of use 109.709 acres within the SE 1/4 Section 33, T.3S.,

R.55E., M.D.M.

8. Existing place of use 7.5 acres from each of the three following Describe by legal subdivisions. If permit is for irrigation, state number of acres irrigated. If changing place of use and/or

subdivisions: 7.5 acres from Lot 1 (NE 1/4 NE 1/4) Sec.2, T.4S., R.55E.

Applicants are submitting this and companion temporary change applications so that the contemplated irrigation change scheme can be placed into operation at the earliest possible time in the current irrigation season. Permanent change applications for the same rights, or portions of rights, will be submitted, with map, upon completion of the installation of the new improvements. A subsequent change application will be filed to change the place of use of the remaining 97.5 acres supplied from the original point of diversion under #45085, a new configuration (pivot).

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This temporary permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 45085, Certificate 12236 is issued subject to the terms and conditions imposed in said Permit 45085, Certificate 12236 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 57843-T, 57844-T, 57845-T and 57932-T shall not exceed 667.5 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on September 8, 1993 at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The acreage under this permit and Permits 57843-T, 57844-T and 57932-T is limited to 133.5 acres within the SE $\frac{1}{4}$  of Section 33, T.3S., R.55E.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to

exceed..... 0.16 cubic feet per second, but not to exceed 112.50 acre-feet annually, and not to exceed an annual duty of 5.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before.....
