1. The source of water is Underground

2. The amount of water to be changed .108 c.f.s. (N.T.E. 21.6 acre-feet annually)
Second feet, acre feet. One second foot equals 448.83 gallons per minute.

3. The water to be used for Quasi-Municipal & Domestic
Irrigation, power, mining, industrial, etc. If for stock state number and kind of animals.

4. The water heretofore permitted for Irrigation & Domestic
Irrigation, power, mining, industrial, etc. If for stock state number and kind of animals.

5. The water is to be diverted at the following point SE 1/4 SE 1/4 Section 8, T.16N., R.20E., M.D.B.&M.,
Describe as being within a 40-acre subdivision of public survey and by course and at a point from which the NE cor. of said Section 8 bears N. 14° 00' 00" E., a distance of 4844.0 feet.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 50992, Certificate 12508 is issued subject to the terms and conditions imposed in said Permit 50992, Certificate 12508 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 57915, 57916, 57991, 57992, 57993 and 57994 shall not exceed 243.26 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to

exceed 0.108 cubic feet per second, but not to exceed 21.58 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before April 23, 1994

Proof of completion of work shall be filed before May 23, 1994

Application of water to beneficial use shall be made on or before April 23, 1998

Proof of the application of water to beneficial use shall be filed on or before May 23, 1998

Map in support of proof of beneficial use shall be filed on or before N/A
