hereby make application for permission to change the Point of Diversion of a Portion of water heretofore appropriated under Permit 52421

- 1. The source of water is Underground
2. The amount of water to be changed 0.2370 cfs
3. The water to be used for Irrigation and Domestic
4. The water heretofore permitted for Irrigation and Domestic
5. The water is to be diverted at the following point Within the SW 1/4 NE 1/4 Section 4, T.17N., R.20E., M.D.M. from which the East one-quarter corner of said Section 4 bears distance to a section corner. If on unsurveyed land, it should be stated. South 80 00' East, 2250 feet distant.
6. The existing permitted point of diversion is located within the NE 1/4 SE 1/4 of Section 4, T.17N., R.20E., M.D.M. from which the East One-Quarter corner of said Section 4 bears North 73 00' East, 800 feet distant.
7. Proposed place of use Portion of the W 1/2 NE 1/4 and Portion of the SE 1/4 of Section 4: S 1/2 SW 1/4 and a Portion of the NW 1/4 SW 1/4 of Section 3, T.17N., R.20E., M.D.M. Containing 160 acres more or less.
8. Existing place of use Same as above
9. Use will be from January 1 to December 31 of each year.
10. Use was permitted from January 1 to December 31 of each year.
11. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Drilled well, pump, motor, distribution pipes and ditches.
12. Estimated cost of works \$40 000.00
13. Estimated time required to construct works 1 Year

14. Estimated time required to complete the application of water to beneficial use 2 years

APPROVAL  
OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of a portion of the waters of an underground source as heretofore granted under Permit 52421 is issued subject to the terms and conditions imposed in said Permit 52421 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The well must be sealed with cement grout, concrete grout or neat cement from ground level to 100 feet.

The total combined duty of water under Permits 52420, 52421, 52422, 52450, 58434 and 58435 shall not exceed 640.0 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.237 cubic feet per second, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before July 3, 1996

Proof of completion of work shall be filed before August 3, 1996

Application of water to beneficial use shall be made on or before July 3, 1997

Proof of the application of water to beneficial use shall be filed on or before August 3, 1997

Map in support of proof of beneficial use shall be filed on or before August 3, 1997
