hereby makeS application for permission to change the Point of Diversion, Manner and Place of Use of a Portion of water heretofore appropriated under Permit 50071 (Certificate 12436)

1. The source of water is Musgrove Creek & Tributaries

2. The amount of water to be changed 0.029 c.f.s. (Not to Exceed 5.0 a.f.a.)

3. The water to be used for Irrigation and Domestic

4. The water heretofore permitted for Irrigation and Stockwater

5. The water is to be diverted at the following point NE 1/4 SW 1/4 Section 22, T.16N., R.19E., M.D.B.&M., or at a point from which the S 1/4 corner of said Section 22 bears S. 25° 42' 00" E., a distance of 2462.24 feet.

6. The existing permitted point of diversion is located within SW 1/4 NW 1/4 Section 27, T.16N., R.19E., M.D.B.&M., or at a point from which the NW corner of said Section 27 bears N. 14° 54' 16" W., a distance of 1825.00 feet.

7. Proposed place of use Portion of the SW 1/4 NW 1/4; Portions of SE 1/4 NW 1/4; Portions of NW 1/4 SW 1/4; Portions of NE 1/4 SW 1/4; all within Section 22, T.16N., R.19E., M.D.B.&M., otherwise described as Washoe County APN 55-190-07.

8. Existing place of use Refer to Exhibit "A"

9. Use will be from January 1 to December 31 of each year.

10. Use was permitted from As Decreed to of each year.

11. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Concrete diversion gate, pump and pipeline to Proposed Place of Use.

12. Estimated cost of works \$5,000.00

13. Estimated time required to construct works 2 Years

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place of use and manner of use of the waters of Musgrove Creek and Tributaries as heretofore granted under Permit 50071, Certificate 12436 is issued subject to the terms and conditions imposed in said Permit 50071, Certificate 12436 and with the understanding that no other rights on the source will be affected by the change proposed herein. A substantial headgate and measuring device must be installed and maintained to facilitate the measurement and control of water. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 58731, 58732, 58733 and 58962 shall not exceed 5.0 acre-feet annually and is limited to the irrigation of 1.25 acres within the place of use.

All surface water shall be used for irrigation prior to any use of the supplemental groundwater.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.029 cubic feet per second but not to exceed 5.0 acre-feet as decreed, and not to exceed as decreed a duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before September 9, 1996

Proof of completion of work shall be filed before October 9, 1996

Application of water to beneficial use shall be made on or before September 9, 1999

Proof of the application of water to beneficial use shall be filed on or before October 9, 1999

Map in support of proof of beneficial use shall be filed on or before October 9, 1999

Completion of work filed OCT 25 1996

Proof of beneficial use filed NOV 18 1999

Cultural map filed NOV 18 1999
