APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of Musgrove Creek and Tributaries as heretofore granted under Permit 50071, Certificate 12436 is issued subject to the terms and conditions imposed in said Permit 50071, Certificate 12436 and with the understanding that no other rights on the source will be affected by the change proposed herein. A substantial headgate and measuring device must be installed and maintained to facilitate the measurement and control of water. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 59014, 59015, 59016, 59017 and 59018 shall not exceed 5.0 acre-feet annually and is limited to 1.25 acres within the described place of use.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.029 cubic feet per second, but not to exceed 5.0 acre-feet as decreed, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before June 22, 1995

Proof of completion of work shall be filed before July 22, 1995

Application of water to beneficial use shall be made on or before June 22, 1998

Proof of the application of water to beneficial use shall be filed on or before July 22, 1998

Map in support of proof of beneficial use shall be filed on or before July 22, 1998
