of water heretofore appropriated under Permit 50071, Certificate 12436

identify right in Decree.

1. The source of water is Musgrove Creek and Tributaries

2. The amount of water to be changed 0.029 CFS - 5.0 Acre Feet

3. The water to be used for irrigation and stockwater

4. The water heretofore permitted for irrigation and stockwater

5. The water is to be diverted at the following point within the SE 1/4 SW 1/4 of Section 22, T16N, R19E, MDM, or at a point from which the SW corner of the said Section 22 bears S. 58 deg. 50 min. W., a distance of 1,835.0 feet.

6. The existing permitted point of diversion is located within the SW 1/4 NW 1/4 of Section 27, T16N, R19E, MDM, or at a point from which the NW corner of the said Section 27 bears N. 14 deg. 54 min. 16 sec. W., a distance of 1,825.0 feet.

7. Proposed place of use within a portion of the SW 1/4 SW 1/4 and a portion of the SE 1/4 SW 1/4 of Section 22, T16N, R19E, MDM, Washoe County Assessor's parcel number 055-200-64. Total - 5.00 acres

8. Existing place of use Within the NE 1/4 SW 1/4 of Section 23, T16N, R19E, MDM. Total - 1.25 acres.

9. Use will be from January 1st to December 31st of each year.

10. Use was permitted from January 1st to December 31st of each year.

11. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Install concrete weir with adjustable headboards to divert to pipeline to property.

12. Estimated cost of works at least \$1,000

13. Estimated time required to construct works One (1) year

14. Estimated time required to complete the application of water to beneficial use Five (5) years

15. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use:

Water under this Application will be comingled with other water rights held by the applicant to cultivate lawn, garden and pasture appurtenant to APN 055-200-64 in Washoe County, Nevada. Use of overhead sprinklers and drip irrigation systems.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of Musgrove Creek and Tributaries as heretofore granted under Permit 50071, Certificate 12436 is issued subject to the terms and conditions imposed in said Permit 50071, Certificate 12436 and with the understanding that no other rights on the source will be affected by the change proposed herein. A substantial headgate and measuring device must be installed and maintained to facilitate the measurement and control of water. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 59030, 59031, 59032, 59033 and 59034 shall not exceed 5.0 acre-feet annually and is limited to 1.25 acres within the described place of use. All surface waters must be used for irrigation prior to the use of any of the supplemental groundwater.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.029 cubic feet per second, but not to exceed 5.0 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before September 29, 1995

Proof of completion of work shall be filed before October 29, 1995

Application of water to beneficial use shall be made on or before September 29, 1998

Proof of the application of water to beneficial use shall be filed on or before October 29, 1998

Map in support of proof of beneficial use shall be filed on or before October 29, 1998
