Point of Diversion and Place of Use of a Portion
of water heretofore appropriated under Permit 24194 Certificate 7378

- 1. The source of water is Underground
2. The amount of water to be changed 480.0 Acre Feet 2.15 c.f.s.
3. The water to be used for Irrigation & Domestic
4. The water heretofore permitted for Irrigation & Domestic
5. The water is to be diverted at the following point within the SW 1/4 of the NW 1/4 of Sec. 35, T6N, R66E, M.D.M., at a point from which the Northwest Corner of said Section 35 bears N 01° 27' 41" W a distance of 1,330.38 feet. (Lincoln County)
6. The existing permitted point of diversion is located within NE 1/4 of the NE 1/4 of Sec. 26, T9N, R65E, M.D.M., at a point from which the SE Corner of said Section 26 bears S 14° 45' E a distance of 4,250.0 feet. (Lincoln County)
7. Proposed place of use NW 1/4 of Section 35, T6N, R66E, M.D.M., containing 160.0 acres - of which 120 acres will be irrigated by this pivot (480 acres feet of water will be utilized) (Lincoln County)
8. Existing place of use 22.515 Ac. in the NE 1/4 NE 1/4, Sec. 26; and 40.742 Ac. in the NW 1/4 NW 1/4; & 11.652 Ac. in the NE 1/4 NW 1/4; & 5.372 Ac. in the SE 1/4 NW 1/4; & .424 Ac. in the NE 1/4 SW 1/4; & 39.295 Ac. in the SW 1/4 NW 1/4, Sec. 25,; all T9N, R65E, M.D.M., (Lincoln County)
9. Use will be from January 1st to December 31st of each year.
10. Use was permitted from January 1st to December 31st of each year.
11. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage-works.) Well will be drilled and cased to a depth sufficient to service a rotary pivot system. Lines will be installed to supply pivot.
12. Estimated cost of works \$40,000.00
13. Estimated time required to construct works 3 years

14. Estimated time required to complete the application of water to beneficial use. 3 years.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 24194, Certificate 7378 is issued subject to the terms and conditions imposed in said Permit 24194, Certificate 7378 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a measuring device must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.15 cubic feet per second, but not to exceed 480.0 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before May 17, 1997

Proof of completion of work shall be filed before June 17, 1997

Application of water to beneficial use shall be made on or before May 17, 2000

Proof of the application of water to beneficial use shall be filed on or before June 17, 2000

Map in support of proof of beneficial use shall be filed on or before June 17, 2000
