hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is unnamed spring

2. The amount of water applied for is one second-foot

5. The water is to be diverted from its source at the following point being within lot 2 of Section 3, T27N, R23E, M.D.M., from which point the S.E. corner of Section 34, T28N, R23E, M.D.M., bears N86°24'27"E a distance of 1,911.01 feet

6. Place of use NE 1/4 SE 1/4, and lots 1 and 2 of Section 3, T27N, R23E, M.D.M. and lot 3 of Section 34, T28N, R23E, M.D.M.

7. Use will begin about January 1, and end about December 31, of each year.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. A substantial headgate and measuring device must be installed and maintained to facilitate the measurement and control of water. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 59126, 59127, 59128, 59129, 59130 and 59131 shall not exceed 712.0 acre-feet annually.

This permit is subject to the condition that the permittee must ensure that wildlife which have customarily used such water will have access thereto, NRS 533.367.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.005 cubic feet per second, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before November 29, 1997

Proof of completion of work shall be filed before December 29, 1997


