The applicant **Timothy O. & Scott B. Tucker**, hereby make application for permission to change the **Point of Diversion, Place and Manner of Use** of water heretofore appropriated under a portion of Permit No. 49072, Cert. 12014

1. The source of water is **Underground**
2. The amount of water to be changed **61.44 A.F. 0.1692 C.F.S.**
3. The water to be used for **Municipal**
4. The water heretofore permitted for **Irrigation**
5. The water is to be diverted at the following point **Lot 4, Section 7, T.20N., R.21E., M.D.M. at a point from which the SW corner of said Sec. 7 bears South 19 00'00" West, 270 feet. (Big Well)**
6. The existing permitted point of diversion is located within the **NE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 18, T.20N., R.21E., M.D.M. at a point from which the E $\frac{1}{4}$ corner of said Section 18 bears North 78°55' East, 690.0 feet.**
7. Proposed place of use **the certificated water service territory of Sierra Pacific Power Company as described in the legal description and shown on the map on file with the State Engineers Office, Division of Water Resources, State of Nevada, and Washoe County Utility services area- see attached Item 7.**
8. Existing place of use **40.0 Acres within SE $\frac{1}{4}$ NE $\frac{1}{4}$ and 18.364 Acres within N $\frac{1}{2}$ NE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 18, T.20N., R.21E., M.D.M. (Includes 0.464 Acres within the 2.0 acres shown to be stripped on the map supporting Application 55806.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **April 15th to October 15th** of each year.
11. Description of proposed works **Well, electric pump, pipelines, storage tanks and distribution system.**
12. Estimated cost of works **\$150,000**
13. Estimated time required to construct works **4 YEARS**
14. Estimated time required to complete the application of water to beneficial use **10 YEARS**
15. Remarks: **The intent of this application is to change the Point of Diversion, Place and Manner of Use of these rights from agricultural to municipal for development of future subdivisions and/or a golf course.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place of use and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 49072, Certificate 12014 is issued subject to the terms and conditions imposed in said Permit 49072, Certificate 12014 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 59345, 59871 and 59872 shall not exceed 227.94 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.1692 cubic feet per second, **but not to exceed 61.44 acre-feet annually.**

Work must be prosecuted with reasonable diligence and be completed on or before:

June 30, 2000

Proof of completion of work shall be filed before:

July 30, 2000

Application of water to beneficial use shall be filed on or before:

June 30, 2004

Proof of the application of water to beneficial use shall be filed on or before:

July 30, 2004




