This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use of the waters of the Truckee and Carson Rivers as set forth under the Newlands Reclamation Project rights in the Truckee and Carson River final decrees is issued subject to the terms and conditions imposed in said decrees and with the understanding that no other rights on the source will be affected by the change proposed herein.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed _____ cubic feet per second' but not to exceed 27.30 acre-
feet as decreed.

Work must be prosecuted with reasonable diligence and be completed on or before August 14, 1996

Proof of completion of work shall be filed before September 14, 1996

Application of water to beneficial use shall be made on or before August 14, 1999

Proof of the application of water to beneficial use shall be filed on or before September 14, 1999


