The applicant City of Elko, hereby makes application for permission to change the Point of Diversion of a Portion of water heretofore appropriated under Permit 56588

\*\*\*\*\*

1. The source of water is Underground Well 1-96
2. The amount of water to be changed 3.0 cfs
3. The water to be used for Municipal & Domestic
4. The water heretofore permitted for Municipal & Domestic
5. The water is to be diverted at the following point NW $\frac{1}{4}$  SE $\frac{1}{4}$  of Section 30, T 35 N, R 56 E, MDB&M. at a point from which the West  $\frac{1}{4}$  corner of said Section 30 bears N 84° 43' 10" W, 2640.40 feet.
6. The existing permitted point of diversion is located within SE $\frac{1}{4}$  NE $\frac{1}{4}$  of Section 10, T 34 N, R 55 E, MDB&M., at a point from which the NE corner of said Section 10 bears N 19° 30' 00" E, 2250.00 feet.
7. Proposed place of use All of Sections 25 & 36, T 35 N, R 55 E, MDB&M., All of Sections 30 & 31, T 35 N, R 56 E, MDB&M., Section 6, T 34 N, R 56 E, MDB&M., All of Sections 1, 2, 3, 4, 5, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 20, 21, 22, 23, & 24, T 34 N, R 55 E, MDB&M.
8. Existing place of use Same as Above
9. Use will be from January 1 to December 31 of each year.
10. Use was permitted from January 1 to December 31 of each year.
11. Description of proposed works Drilled Well, Pump, Motor & Pipelines to Place of Use
12. Estimated cost of works \$200,000
13. Estimated time required to construct works 5 years
14. Estimated time required to complete the application of water to beneficial use 10 years
15. Remarks: The estimated consumptive use under this application is 2171.50 acre feet per year.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of a portion of the waters of an underground source as heretofore granted under Permit 56588 is issued subject to the terms and conditions imposed in said Permit 56588 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

The issuance of this permit expires temporary permit 62094-T.

The total combined duty of water under Permits 7381, Certificate 1207; 9446, Certificate 2494; 10185, Certificate 2744; 14474, Certificate 4824; 14475, Certificate 4825; 14476, Certificate 4469; 14477, Certificate 4470; 15979, Certificate 5370; 23985, Certificate 9848; 24801, Certificate 7513; 26326, Certificate 9790; 29061, Certificate 8791; 36626, 37221, Certificate 11134; 43373, 43374, 44073, 48277, Certificate 13798; 49515, 49617, Certificate 13044; 51994, 51995, 52854, 54142, 56588, 56589, 56590, 59766, 61712 and 61714 shall not exceed 18,000.0 acre-feet annually.

(PERMIT TERMS CONTINUED)

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 3.0 cubic feet per second , but not to exceed 2,171.5 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before:

October 1, 1997

Proof of completion of work shall be filed before:

November 1, 1997

Application of water to beneficial use shall be filed on or before:

October 1, 2006

Proof of the application of water to beneficial use shall be filed on or before:

November 1, 2006


