The applicant SPANISH SPRINGS ASSOCIATION AND WASHOE COUNTY, A POLITICAL SUBDIVISION OF THE STATE OF NEVADA, hereby makes application for permission to change the POINT OF DIVERSION, PLACE OF USE & MANNER OF USE OF A PORTION of water heretofore appropriated under PERMIT 48921 (CERT. 12072)

1. The source of water is UNDERGROUND
2. The amount of water to be changed SEE EXHIBIT B
3. The water to be used for MUNICIPAL
4. The water heretofore permitted for COMMERCIAL & DOMESTIC
5. The water is to be diverted at the following point SE $\frac{1}{4}$ SE $\frac{1}{4}$ SECTION 34, T21N, R20E, MDB&M, OR AT A POINT FROM WHICH THE SE CORNER OF SAID SECTION 34 BEARS S 56 DEGREES 17' E., A DISTANCE OF 226 FEET. (REFER TO MAP UNDER PERMIT 57688 FOR PROPOSED POINT OF DIVERSION)

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place of use and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 48921 Certificate 12072 is issued subject to the terms and conditions imposed in said Permit 48921 Certificate 12072 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.234 cubic feet per second, but not to exceed 104.4 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before:

May 16, 1998

Proof of completion of work shall be filed before:

June 16, 1998

Application of water to beneficial use shall be filed on or before:

May 16, 2007

Proof of the application of water to beneficial use shall be filed on or before:

June 16, 2007
