The applicant **South Meadows Properties Limited Partnership** as to a **83% Interest** and **Washoe County** as to a **17% Interest**, hereby make application for permission to change the **point of diversion, place of use and manner of use** of a portion of water heretofore appropriated under **Proof of Appropriation #05654**.

1. The source of water is **underground**
2. The amount of water to be changed **0.1988 CFS** not to exceed **95.40 acre feet annually**
3. The water to be used for **municipal**
4. The water heretofore permitted for **irrigation, domestic, stockwater**
5. The water is to be diverted at the following point **SW $\frac{1}{4}$ NW $\frac{1}{4}$ Section 9, T.18N., R.20E., M.D.B.&M** or at a point from which the Northeast corner of Section 4, T.18N., R.20E., M.D.B.&M. bears N. 29°12'49" E., a distance of 8757.12 feet. See Map supporting Application #61879.
6. The existing permitted point of diversion is located within **SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 4, T.18N., R.20E., M.D.B.&M**. Proof of Appropriation #05654 does not specify a bearing and tie to the existing point of diversion.
7. Proposed place of use See Application #61742 and supporting Map for SPPCo. place of use. See Permit #57410 and supporting Map for Washoe County place of use.
8. Existing place of use **Section 4, T.18N., R.20E., M.D.B.&M. NW $\frac{1}{4}$ SW $\frac{1}{4}$ - 31.8 acres.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **water will be diverted from a proposed well to existing and future customers of Washoe County and SPPCo. through existing and future distribution systems and appurtenances.**
12. Estimated cost of works **in excess of \$750,000**
13. Estimated time required to construct works **three years**
14. Estimated time required to complete the application of water to beneficial use **ten years**
15. Remarks: **Irrigation of lands within the existing place of use is also covered by Proofs of Appropriation #03509 to and including #03511.**
