The applicant **Oakspring Associates**, hereby make application for permission to change the **point of diversion, place of use and manner of use of a portion of water heretofore appropriated under Permit #29646, Certificate #9098**

1. The source of water is **underground**
2. The amount of water to be changed **0.3375 CFS not to exceed 75.00 acre feet annually**
3. The water to be used for **recreation (golf course irrigation) and domestic**
4. The water heretofore permitted for **irrigation and domestic**
5. The water is to be diverted at the following point **NE 1/4 SW 1/4 Section 12, T.20N., R.20E., M.D.B.&M., or at a point from which the East 1/4 corner of said Section 12 bears N.87°07'25"E., a distance of 2756.69 feet.**
6. The existing permitted point of diversion is located within **SW1/4 SE1/4 Section 26, T.21N., R.20E., M.D.B.&M., or at a point from which the Northeast corner of Section 24, T.21N., R.20E., M.D.B.&M. bears N.35°38'30"E., a distance of 12500.81 feet.**
7. Proposed place of use **Section 13, T.20N., R.20E., M.D.B.&M. NE 1/4NW 1/4 - 18.75 acres**
8. Existing place of use **Section 26, T.21N., R.20E., M.D.B.&M. SE1/4 SW1/4 - 0.39 acres; SW1/4 SE1/4 - 2.2325 acres Section 35, T.21N., R.20E., M.D.B.&M. NE1/4 NW1/4 - 2.32 acres NW1/4 NE1/4 - 13.8075 acres TOTAL 18.75 acres**
9. Use will be from **January 1 to December 31 of each year.**
10. Use was permitted from **January 1 to December 31 of each year.**
11. Description of proposed works **Water will be diverted from an existing well into storage ponds and distributed to the proposed place of use by means of golf course irrigation system.**
12. Estimated cost of works in excess **\$500,000**
13. Estimated time required to construct works **three years**
14. Estimated time required to complete the application of water to beneficial use **ten years**
15. Remarks: **Water will be used for irrigation of the Wingfield Springs Golf Course**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 29646 Certificate 9098 is issued subject to the terms and conditions imposed in said Permit 29646 Certificate 9098 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.3375 cubic feet per second, but not to exceed 75.0 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before:

May 13, 1997

Proof of completion of work shall be filed before:

June 13, 1997

Application of water to beneficial use shall be filed on or before:

May 13, 2001

Proof of the application of water to beneficial use shall be filed on or before:

June 13, 2001


